The Office of the Vice President for Research has been working on the release of the new Grants module within the Enterprise Research Management System (ERMS)

ERMS-Grants Module

ERMS-Grants will provide a modernized IT solution supporting sponsored programs activities throughout their life cycle, from proposal submission through award closeout. As the institution's research infrastructure grows, implementation of ERMS-Grants brings many advancements including streamlined workflows, process improvements, and the long-awaited elimination of the paper-based Certificate of Proposal (COP) form. In addition, current active awards will be integrated into ERMS-Grants and will be available for investigators and their support teams when the module goes live.

The module is anticipated to go live in late summer 2025. Investigators will be able to continue utilizing Cayuse424 for submission of federal applications through grants.gov through November 2025. In the coming months, the Office of Sponsored Programs (OSP) will be providing informational meetings and various training opportunities in several formats to meet the needs of investigators and staff.


ERMS-IACUC Module Tips and Tricks

NRHR Auto-Determination Tool - Coming Soon!

The IRB Office is testing a tool for PIs to determine whether their project meets the federal definition of human research (45 CFR 46). For studies falling outside IRB oversight – QA/QI, program evals, or research with unidentifiable samples – PIs can obtain an informal determination. (Note that this is different from Exempt research, which still requires review by the IRB Office, per HOP 7.2.1).
